

General Liability Release

In exchange for participation in the Bjørnetann Language and Cultural Camp organized by District IV of the Sons of Norway, and /or the use of the property, facilities and services of the Red Lodge Lion's Club camp, agree for myself and (if applicable) for the member of my family to the following:

1. **AGREEMENT TO FOLLOW DIRECTIONS.** I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by the employees, representatives or agents of the Bjørnetann Language and Cultural Camp including but not limited to class instructors, kitchen staff, and the members of the board of directors of the camp.
2. **ASSUMPTION OF THE RISKS AND RELEASE.** I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members and further release and discharge Bjørnetann Language and Cultural Camp, their employees, board members, Sons of Norway District IV, and the Red Lodge Lion's Club for injury loss or damage arising out of my or my family's use of or presence upon the facilities of the camp, whether caused by the fault of myself, my family, or other third parties.
3. **INDEMNIFICATION.** I agree to indemnify and defend Sons of Norway District IV, Bjørnetann Language and Cultural Camp, the employees and board of directors of the camp and the Red Lodge Lion's Club against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the facilities of the camp.
4. **FEES.** I agree to pay for all damages to the facilities of the Red Lodge Lion's Club Camp, the Bjørnetann Language and Cultural Camp caused by any negligent, reckless, or willful actions by me or my family.
5. **APPLICABLE LAW.** Any legal or equitable claim that may arise from the participation in the above shall be resolved under Montana Law.
6. **NO DURESS.** I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review it before signing. I further agree and acknowledge that I am free to have my own legal counsel review this Agreement if I so desire. I further agree and acknowledge that Bjørnetann Language and Cultural Camp has offered to refund any fees that I have paid if I choose not to sign this agreement.
7. **ENFORCEABILITY.** The invalidity or unenforceability of any provision of this Agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the

validity or enforceability of any other provision of this Agreement or of any other applications of such provision as the case may be, and such invalid or unenforceable provision shall be deemed not to be part of this agreement.

8. EMERGENCY MEDICAL CARE. I agree that if I am in need of medical care and am unable to consent to same that the Bjørnetann Language and Cultural Camp, their staff or agents have my permission to provide for/ or arrange for emergency medical care and I shall not hold them liable for any damages arising from same.

9. DISPUTE RESOLUTION. The parties will attempt to resolve any dispute arising out of or relating to this Agreement through friendly negotiations amongst the parties. If the matter is not resolved by negotiation, the parties will resolve the dispute using the below Alternative Dispute Resolution (ADR) procedure.

Any controversies or disputes arising out of or relating to this Agreement will be submitted to mediation in accordance with any statutory rules of mediation. If mediation does not successfully resolve the dispute, then the parties may proceed to seek an alternative form of resolution in accordance with any other rights and remedies afforded to them by law.
